Educating the children of migrants
Own-initiative report (2008/2328(INI))
Rapporteur: Hannu Takkula (ALDE, FI)

The draft report was adopted with amendments. The report stresses that for the full integration of migrants it is fundamental to have greater support for language courses and that integration is a two-way process involving both the host country and migrants.

Rapporteur: Pal Schmitt (EPP-ED, HU)

The report was adopted with most of the proposed amendments. It stresses the importance of high quality school education for every child, independently of his or her background. Improving quality and access is vital given rapidly changing labour markets and, even more so, for each child's personal development. The report also underlines the value of European cooperation on the issue and supports the Commission's proposal to base future cooperation on updated and new benchmarks.

The experts made presentations on the role of public broadcasters in the new audiovisual landscape and on future strategies to cope with changes and opportunities arising from technological developments. The presentations often referred to the Commission's forthcoming Communication on state aid to public broadcasters. Speakers also stressed the importance of the subsidiarity principle, of public broadcasters appealing to a wide public by offering a wide range of high-quality programmes, and the reciprocal relationship between private and public media.

Exchanges of views

Exchange of views on the Media Mundus proposal with Valerio Caruso (Project Manager, Cineuropa), Alan Fountain (Chief Executive, EAVE, European Audiovisual Entrepreneurs) and Claude-Eric Poiroux (Director General, Europa Cinemas)

Mr. Fountain addressed training and project development in broad terms with some reference to a European/Latin American project for producers funded by MEDIA International.

Mr. Caruso gave an analysis of the different types of funding and grants provided by the European Commission, in particular Euromed Audiovisual and ACP Cinema programme and suggested in this respect concrete ideas to improve the existing programmes.

Mr. Poiroux underlined the importance of international cooperation in the audiovisual sector, and explained how the future Media Mundus programme will foster this cooperation.

Delegation to Linz, February 2009

On 25 - 27 February a delegation of the Committee on Culture and Education visited Linz as one of the European capitals of culture in 2009.

The European Capital of Culture event gives European cities the opportunity to present a cultural programme lasting around a year, highlighting the richness, diversity and shared characteristics of Europe's cultures. Over the past 20 years, the event has routinely attracted substantial media attention and has promoted the cultural, and perhaps economic, development of the cities concerned.

Linz, in 2005, was designated the Austrian candidate for European Capital of Culture 2009. The programme for the year includes more than 220 projects with 6500 activities, delivered in collaboration with major cultural institutions, artists, performers and venues throughout Linz and the region.

The delegation visited the most important venues and infrastructural projects and held exchanges of views with the organising team of Linz09 as well as with the political representatives of the city and the region. The delegation came to the conclusion that the festival programme lived up to the conditions and the spirit of the "European capital of culture" action. It showed a wide range of activities with a European dimension, involved the local population as well as the region and contained a number of elements with a long-lasting effect on the city's life.
