### **Community participation in the European Audiovisual Observatory**

#### **Own-initiative report**

**Rapporteur: Ivo Belet (EPP-ED, BE)**

Mr. Belet emphasised that the Observatory is the only pan-European public service organisation which gathers and distributes detailed information on the European audiovisual industry. He urges the Observatory to extend its activities to cover the latest challenges created by media convergence and technological innovation, by giving more attention to online audiovisual services.

In particular, measures must be taken to ensure that all the fundamental rights of persons are always safeguarded and protected. He also stressed that, due to their economic and cultural nature, cultural expressions should be protected from abuse on the Internet.

The draft opinion presented in committee focuses on the implementation of the Commission budget in the areas of education, culture, media, active citizenship and communication. The draftswoman welcomed improvements - better control mechanisms and fewer late payments - in the management of the multiannual programmes run by DG EAC, the Executive Agency and national agencies. She also expressed her hope that, if DG COMM improved its control mechanisms, the reservations expressed about its budget management in 2007 might be answered.
